GENERAL

1. SITE MAP: The Site Map for the event can be found at https://www.springmountraceway.com/events/northern-nats-2021/

2. EVENT SCHEDULE: Event Schedule can be found at

Springmount Raceway reserves the right to amend the schedule as required due to weather or any other matters which are considered to be in the best interests of the overall event.

- **3. COMPETITOR ENTRIES:** All competitor entries are to be completed online at http://www.springmountraceway.com/events/northern-nats-2021/. Event organisers reserve the right to refuse entry of any vehicle if deemed to be inappropriate or not of a sufficient standard befitting the event.
- **4. COMPETITOR ENTRY FEES:** Entry fees are payable immediately upon online registration if paying by PayPal or within 5 days of online registration if paying by bank transfer. Failure to pay promptly may result in late nomination fees or cancellation of your nomination.
- **5. ENTRY CLOSING DATE:** Entries close on April 23rd, after which Late Entries apply.
- **6. LATE ENTRIES:** A \$50 late entry fee applies from April 24th and late entries will close on May 4th. Entries may also be accepted on the gate but will be subject to availability and further late fees. No guarantees are made that entry on the gate will be accepted.
- **7. ENTRY REFUND POLICY:** To obtain a refund on competitor entry, you must inform Springmount Raceway at contact@springmountraceway.com, no later than 72 hours prior to the commencement of the event.
- **8. CAMPING/COMPETITOR GATE OPEN TIMES:** Camping/competitor gates will be open from:

Thursday from 12 midday – 10pm Friday from 7am – 10pm Saturday from 7am – 10pm Sunday from 7am - Monday 9am



Any access to the camping/competitor grounds outside of these hours will need to be pre-arranged.

9. COMPETITOR/CREW GATE PROCEDURES: Please ensure that online entry ticket is brought to the competitor gate upon entry. Competitors will be given a ticket which is to be presented at the Scrutineering Shed when signing-in and undertaking scrutineering. A competitor armband will then be issued by officials once scrutineering has been completed.

Pit crew will follow the same procedure as competitors, although pit crew tickets may also be available to purchase on the gate if a competitor's allocation has not been used up.

- **10. COMPETITOR, CREW AND OFFICIALS INDEMNITY:** All entrants, crew, officials and all persons with access to Restricted Areas are required to sign an indemnity at the Scrutineering Shed prior to competition and must wear the relevant armband at all times.
- **11. DRIVERS BRIEF:** A driver's brief will be held each morning in the staging lanes near the Drag Strip Start Line/Tower (check Event Schedule for times). All entrants and crew must attend the briefs.
- **12. PIT/CAMPING AREA ALLOCATIONS:** Allocation of pit/camping areas is at the discretion of Track officials. Generally, race/competition cars will be given priority use of sealed pit areas over street cars.

Camps comprising tents, makeshift tarps, etc, will be limited to the "outer" areas of the Pit Area and Camping Areas. The "inner" parts of the Pit Area and parts of the Event Area are to be for enclosed trailers, car displays and the like. For details of these areas, see the Site Map.

13. RESTRICTED AREA: The Restricted Area is defined as: The entire Drag Strip, Burnout Pad and Return Road bounded by the spectator fences and includes the line-marked Staging Lanes. See the Site Map for details.

The Restricted Area can only be accessed by racers, crew and officials who have signed the indemnity and are authorised to do so. Crew aged between 8 and 14 years of age can access this area only during Junior Dragster competition.

- **14. TOW VEHICLES:** All persons in each tow vehicle must remain inside the confines of the vehicle while moving. Standing up in the rear of utilities, trucks and other like vehicles is not permitted. Competitors are requested to limit the number of people in the tow car. The return road is two-way traffic. Vehicles must keep left with no stopping.
- **15. ALCOHOLIC BEVERAGES/GLASS:** Alcohol may be brought into the Camping Area and Pit Area ONLY but may not be consumed within the Pit Area or any entrant campsites (even if within the Camping Area) until driving events have concluded. For details of these areas, see the Site Map. Entrants and pit crew may be randomly breath-tested and must return zero readings while competing or being within a Restricted Area. No glass containers (stubbies, bottles, jars etc) are permitted in the Pit Area at any time.

The Event Area is licensed and strictly no BYO alcohol is allowed. Bags and eskies will be searched upon entry and no open drinks can be brought into the Event Area. Anyone found with BYO alcohol in the Event Area will have their armband removed and will be ejected from the Event Area.

16. FOOD & NON-ALCOHOLIC BEVERAGES: Food and non-alcoholic beverages are permitted to be brought into any areas of the event.



- **17. TRACK FM RADIO:** The track's FM radio broadcast is located on 89FM. The Track Radio (89FM) is used for broadcast of various information during an event.
- **18. EVENT SANCTIONING:** The International Hot Rod Association (IHRA) sanctions Springmount Raceway as a Drag Racing facility. Events will be conducted under the guidelines and regulations laid down by this association.

Some events may be scheduled using other nominated organisations and/or regulations. At all times the safety, class and other rules applicable to the relevant organisation are to be –observed.

Any debate as to the interpretation of regulations shall be determined by IHRA Officials and/or the Meeting Director.

- **19. CURFEW:** Race Engines must not be started before 7am or after 10pm. Campers must be mindful of others and must not make any other excessive noise during these hours.
- **20. SMOKING:** Smoking is only permitted within designated smoking areas along the back of the spectator mounds or in private camp sites. Smoking is not permitted in the Pit Area or Restricted Areas.
- **21. ANIMALS/PETS:** Dogs are permitted in the External Camping Area only (see the Site Map) and must be kept on a lead in the campsite at all times. If there is any excessive noise from barking, both the dog and the owner may be subject to removal from the venue.

Other than registered Guide Dogs accompanying a disabled person, no animals/pets are permitted within the Internal Camping Area, Pit Area or Event Area (see the Site Map).

- **22. VEHICLE REMOVAL:** Any vehicle incorrectly parked may be removed by Springmount Raceway. No responsibility will be accepted by Springmount Raceway for any damage incurred while removing an incorrectly parked vehicle.
- **23. POWER/GENERATORS:** Whilst power is available in parts of the Pit Area, it is limited. Extension cords must be tagged, in good condition and must not cross roads. Entrants and campers should bring their own generators, which must be a quiet, inverter-style, and must be turned off at 10pm.
- **24. WASTE OIL:** Waste oil containers are located near the scrutineering shed. All oil must be disposed of in these containers or removed from the site.
- **25. VEHICLE APPEARANCE:** All competitor vehicles are required to be of neat appearance.
- **26. PRIZEMONEY & TROPHIES:** Prize money, if applicable, will be paid by way of bank transfer after the event. Prize winners are reminded to check their emails for correspondence about this following the event. Prizemoney & Trophy List can be found at

Trophy presentations will be conducted throughout the event – please see the Event Schedule for details.

27. HEALTH AND SAFETY: All competitors have a duty of care to their crew members, other competitors, and the general public, to identify and take measures to eliminate or control hazards or hazardous procedures within their allocated pit space and in any areas where their vehicle may be worked upon, driven or towed. Competitors are required to train, supervise and consult with their crew members in order to eliminate or control risks resulting from such hazards.



All competitors, crew and associates must observe and obey all safety related directions and Occupational Health and Safety requirements that may be given to the competitor, their crew members and associates by the management of Springmount Raceway or its authorised representatives. Failure to act in accordance with such instructions may result in disqualification.

28. DUTY OF CARE – STATEMENT: It is Springmount Raceway's duty to advise you:

That motor racing can be dangerous; your equipment could be damaged or destroyed; and you may suffer serious personal injury or worse.

If there is any aspect of an event that causes you concern for your personal safety or for that of any member of your crew, whether that concern be with the track, the venue or the manner in which

the meeting is being conducted, it is your obligation to bring those concerns to the attention of the Meeting Director or authorised representative. If after doing this those concerns are not addressed to your satisfaction, you are advised to withdraw from the event. It is important that you understand your obligations and rights in this regard.

It is Springmount Raceway's duty to advise you that at any time during this event that random drug and or alcohol testing may take place. If you have any doubts as to your ability to pass such a test with a negative or zero reading you should withdraw from any driving events IMMEDIATELY.

29. SOCIAL MEDIA: Springmount Raceway encourages participation in online social media in a positive manner with freedom of expression. The accessible nature of the Internet however, can lend itself to the posting of threatening and derogatory material in the heat of the moment. Once your thoughts and comments are published to the Internet they are visible to the world - and they are permanent.

Springmount Raceway takes all cases of threatening and derogatory behaviour seriously and will treat online matters as it would 'real world' bullying. Instances of posts not in the best interest will be dealt with in an appropriate manner. Serious consequences including a loss of entrant privileges may be enforced for those who participate in bringing Springmount Raceway and its participants into disrepute.

- **30. COMMERCIAL ARRANGEMENTS:** Springmount Raceway Pty Ltd holds the commercial rights at the venue, including but not limited to sales of food, beverage, signs, sponsorship, trade sites, ticket sales and entry fees. The management of Springmount Raceway reserves the right to remove and/or disqualify any person or company found to be undertaking ambush marketing or any promotion by unauthorised commercial sales, distributing advertising or promotional material or products within the venue.
- **31. COMPETITOR MERCHANDISE SALES:** Competitors and/or teams are permitted to sell driver and team specific apparel and merchandise at Springmount Raceway on the following conditions:
- All products, posters, apparel and merchandise must feature that racer's name and/or team name and/or car identification.
- Sales of team merchandise must be conducted within the allocated pit area.
- Strictly no "commercial" promotional or product giveaways are permitted unless approved by Springmount Raceway prior to the event.

Should a competitor or team wish to market merchandise in variance to this policy this can only be facilitated through a commercial trade site under the applicable costs, terms and conditions.

Springmount Raceway reserves the right to order the withdrawal from sale or display any item or product it considers offensive or inappropriate or violates State or Federal laws.



32. COMPETITOR SPONSOR EXPOSURE: Within the designated pit area, competitors and/or teams are permitted to display team and sponsor signage, banners, flags and relevant promotional material, however the distribution or sampling of any products is not permitted without approval.

The use of promotional personnel is permitted within the team's designated pit area and when the vehicle is on track, however team promotional personnel are not permitted to walk through the venue distributing material or undertaking any promotional activities unless approved by Springmount Raceway.

33. SPONSOR GRAPHICS / ADVERTISING RESTRICTIONS: Springmount Raceway reserves the right to regulate any advertising or other material appearing on any participant and on the body of any vehicle or transporter participating in Springmount Raceway events. Participants and vehicles may be excluded from competition and from event facilities if, in Springmount Raceway management's absolute discretion, any advertising or other material displayed on a person, race or support vehicle, or in a pit area or otherwise is not in the best interests of Springmount Raceway. All advertising, signage and graphic must be suitable for exposure to children attending the events at Springmount Raceway.

DRAG RACING

- **1. COMPETITION:** For those who have entered in the competition (i.e. not just the Test & Tune bracket), a Chicago Shootout will be run on the Saturday and Sunday of the event (check the Event Schedule for details). The shootout forms Round 1 of the Springmount Raceway Track Championship Series and will be run in accordance with the Championship Series Guideline found under the "competitor" tab on the Springmount Raceway website https://www.springmountraceway.com/
- **2. RACER START LINE CREW:** Only Crew that are eligible for the specific classes are permitted to be in the start line area during the pre-race and race of the team's vehicle. All crew should vacate the area immediately after the race.
- **3. JUNIOR DRAGSTER CREW:** Competitors and crew between 8 and 14 years in Junior Dragster are permitted, provided a Parent/Guardian's Acknowledgement of Risk Form is completed.

Permission for minors to enter Restricted Areas can only be given by their legal Parent or Guardian, not by the person responsible for them on the day.

- **4. PASSENGERS:** One (1) passenger is allowed in vehicles competing in the Test & Tune only (not in Chicago Shootout) and only where the vehicle is not capable of running quicker than 13.0 seconds. Passengers must have all safety gear as per driver requirements and must sign an indemnity form at the scrutineering shed. A \$20 fee applies to cover insurance.
- **5. ACCIDENTS AND INCIDENTS ON TRACK:** All crew members and related family and/or friends must not approach the scene of an on-track accident or incident until approved by the track safety crew and officials. Failure to do so or the interference with the track safety staff or officials in any way will result in suspension of racing privileges
- **6. SCRUTINEERING:** Springmount Raceway operates under the IHRA Extended Scrutineering Program (ESP) as per the IHRA rulebook.

Springmount Raceway makes no representation, warranties or assurances that an Audit Inspection including the review of any written information will:



- a) Detect any problem with a race vehicle or a driver/rider's personal equipment or clothing.
- b) Detect any problem with rule compliance.
- c) Prevent injury, death or property damage.

The competitor bares the ultimate responsibility at all times to ensure the safety of their race vehicle and to ensure that they comply with all applicable rules and regulations.

At those events where the IHRA ESP method of auditing is not used all vehicles must present themselves for scrutineering prior to qualifying or testing.

All competitors are required to complete the scrutineering process. Further details about scrutineering and safety requirements can be found at https://www.springmountraceway.com/competitor/technical/

7. COOLANT IN RACE CARS: The use of Glycol based coolants in purpose-built race cars is prohibited.

Genuine street driven vehicles are exempt if they use the vehicle manufacturer's recommended coolant.

- **8. STAGING LANE ALLOCATION:** Staging Lane officials and/or Bracket Marshals will advise staging lane allocations during the event.
- **9. BURNOUTS:** All vehicles running slick tyres are restricted to one (1) across the line burnout. All vehicles running street radials must not cross the start line prior to the start of the race under any circumstances whatsoever; this includes over-staging (putting out the stage beam).

Competitors are reminded that over-staging is grounds for disqualification.

- **10. IN THE HANDS OF THE STARTER:** A reasonable amount of time will be allowed to prepare for the vehicle starting procedure, however failure to start or stalling a vehicle that needs outside assistance to re-start will result in the loss of that qualifier or disqualification in the case of eliminations.
- **11. LEAVING THE RACING SURFACE AFTER A RUN:** At the completion of the run, racers in the Left Lane must give way to the Right Lane as they turn to exit onto the return road. All competitors should familiarise themselves with the nature and locations of the Finish Line, Return Road, Sand Trap, Catch Nets and Exit Points off the Track Surface, prior to their first run on the track.
- **12. ON TRACK BREAKAGES:** Any competitor who aborts a run due to breakage or suspected equipment failure must pull over to the side of the lane and stop as soon as safely possible to minimise the loss of time due to oil downs or track damage.

ROLL RACING

- **1. COMPETITION:** Roll racing will be run in a "heads-up" format based on random pairings from the staging lanes. Depending on the number of entries, competitors will be allowed to keep returning to the staging lanes after each run, regardless of whether they won or lost, until such time that Track Officials decide the run "eliminations". From that point on, competitors that lose the race will be out, while the winner will return to the staging lanes for the next run. Eventually, only two competitors will be left to run the final.
- 2. PROCEDURE: Roll Racing will be run as follows:



- Competitors will undertake the normal staging procedures as per Drag Racing (i.e. burnout and staging at the Start Line).
- When the light goes green on the Christmas Tree, competitors will accelerate to 40km/h and roll together at that speed until the next light (a traffic light positioned further down the track) changes from orange to green, at which stage the competitors race to the finish line).
- **3. OTHER:** All other relevant regulations under the Drag Racing Section above apply to Roll Racing, including the scrutineering process.

POWERSKIDS

- **1. COMPETITION:** Powerskids will be judged not only on distance, but also volume of smoke. A car that has good continuity of smoke will be awarded the win over a car that only slightly hazes the tyres for a longer distance. During the first Powerskid session, competitors can have as many runs as time permits. In the finals, competitors can have three (3) attempts to achieve the best Powerskid.
- **2. PROCEDURE:** Powerskids will be run one (1) vehicle at a time starting from a position behind the Drag Strip Start Line. Competitors may Powerskid to the Drag Strip Finish Line, but no further. Powerskids are to be straight (no fishtailing) and no brakes are to be used to slow the car down during the Powerskid.
- **3. SCRUTINEERING:** Scrutineering of Powerskid competitors will be undertaken as per Drag Racing regulations.
- **4. PASSENGERS:** One (1) passenger is allowed in vehicles competing in Powerskids. Passengers must have all safety gear as per driver requirements and must sign an indemnity form at the scrutineering shed. A \$20 fee applies to cover insurance.

BURNOUTS

- **1. COMPETITION:** Burnouts will be judged in accordance with the Judging Criteria set out below. The competition will be run over three (3) rounds with points tallied up for each round and the winner of each class being the highest points scorer over the three (3) rounds.
- **2. JUDGING CRITERIA:** Points will be allocated on the following basis:
 - Instant smoke max 20 points
 - Constant smoke max 20 points
 - Volume of smoke max 20 points
 - Driver control max 25 points
 - Blown tyres max 5 points (2 points for each tyre, 5 points for both together)
 - Drive of the pad max 10 points
 - TOTAL POINTS max 100 points

Judging stops once tyres are blown except for driving off the pad. Car may be assisted off of any debris under the car but must still drive under its own power. Broken cars cannot be pushed off - only the driver may assist his/her car from the driver's door.



No points will be lost for reversing after the tyres are blown unless the car is stuck against the wall at the time the tyres blow.

Points will not be lost for fires after the tyres are blown, or during a burnout unless you are asked to stop because of the fire.

3. SCRUTINEERING: Burnout entrants will have their vehicles and safety gear checked for the following:

- Vehicles to be of neat and tidy appearance.
- Brakes and steering to be fully functional.
- Automatics must have an operational neutral safety switch.
- No major oil leaks.
- Minimum 600ml coolant overflow tank/bottle.
- Minimum lap sash seat belt.
- Seats to be in good supportive condition and have all mounting bolts fitted.
- No liquid to run through cabin area unless fully enclosed in steel housing approved by scrutineers.
- Battery to be secured (recommended to have an isolation switch).
- Recommended to have transmission shield or blanket.
- Bonnets may be removed if fitted with an electric fan; bonnet must be in place if fitted with a mechanical fan.
- Fuel cells/tanks and battery must be isolated from cabin area.
- Nothing to be sprayed on or placed on tyres.
- Modified floor pan/fire wall and tunnel to be inspected by scrutineers for approval.
- Tyres must be road worthy bald tyres will not permitted.
- Wheel nuts must be standard open nuts mag wheel nuts not permitted on steel rims and all wheel weights must be removed.
- No changes to be made after the vehicle has been scrutineered unless vehicle is to be checked again.

ADDITIONAL CONSIDERATIONS FOR HIGH PERFORMANCE (BLOWN, TURBO) VEHICLES

- Blower Belt guard.
- Harmonic balancer meeting SFI 18.1 requirements.
- Tail shaft loop with 360 degrees of enclosure, minimum 3mm thickness and 50mm width and installed within 150mm from front universal joint.
- Mechanical fuel injection must have fuel shut off to be operational from driver's compartment.
- Manual transmissions are highly recommended to have a clutch shield.

CLOTHING:

- Long pants and long sleeve shirt (no nylon clothing).
- Enclosed shoes.
- Helmet meeting AS1698 (minimum).
- Fire suits highly recommended for any high performance / blown vehicles.



- **4. PASSENGERS:** One (1) passenger per operating door is allowed in vehicles competing in Burnouts. Passengers must have all safety gear as per driver requirements and must sign an indemnity form at the Scrutineering Shed. A \$20 fee applies to cover insurance.
- **5. JUDGING OUTCOMES:** Whilst we sympathize with difficult judging outcomes in what is an interpretive sport, we will not tolerate threats, harassment or excessive misbehaviour from competitors to any official or fellow competitor regarding their specific judging concerns during events, or on social media after the event. A Disqualification will occur in these instances.

All judging enquiries are to be made directly to the Meeting Director of the event only. Judge's scores are final and correspondence will not be entered into. Competitors are not allowed to engage (formally or informally) with official judges. If competitors fail to heed direction in regard to not engaging with judges – their burnout will be disqualified and any prize money forfeited.

CRUISE ROUTE

- **1. GENERAL:** All entrants, other than 'Show & Shine ONLY' can cruise the Cruise Route. For details of the Cruise Route, see the Site Map.
- **2. CONDUCT:** On the Cruise Route entrants are only permitted to do a burnout at the Burnout Pad. Entrants are allowed to do a short, straight skid across the pad, but no static burnouts or donuts. The speed limit is 30 km/h on the Return Road and 20km/h everywhere else. Seatbelts must be worn at all times.
- **3. PASSENGERS:** Passengers are allowed on the Cruise Route but must sign an indemnity form at the Scrutineering Shed. Seatbelts must be worn at all times and a \$20 fee applies to cover insurance.

GO TO WHOA

1. COMPETITION/PROCEDURE: The Go to Whoa will be conducted on the Burnout Pad and requires competitors to accelerate from a standing position and stop at a marked position a short distance away. The time taken to complete the distance and come to a complete stop is recorded and the quickest time is the winner.

SHOW & SHINE

- **1. GENERAL:** All entrants can participate in the Show & Shine. For details of the Show & Shine area, see the Site Map.
- **2. JUDGING:** Judging will occur on the Saturday of the event see the Event Schedule for details. Entrants are permitted, and in fact encouraged, to have their vehicles on display throughout the event, including the Friday and Sunday.
